On September 30, 2025, Union Electric Company d/b/a Ameren Missouri filed its *Request for Variance* requesting that the Commission allow Ameren Missouri an additional thirty days to submit the study anticipated in Paragraph 5.h of the Stipulation<sup>1</sup> in this case, further described in its 2025 Annual Integrated Resource Planning Update.

The Commission will allow responses. The Commission will also direct Staff to file a recommendation regarding Ameren Missouri's request.

### THE COMMISSION ORDERS THAT:

1. No later than October 10, 2025, the Commission's Staff shall file either a recommendation regarding Ameren Missouri's request for variance or a status report advising when it expects to file a recommendation.
2. Any party wishing to respond to this request shall do so no later than October 10, 2025.
3. This order shall be effective when issued.
