On September 26, 2025, The Stoutland Telephone Company d/b/a Rally Networks (Stoutland), filed the above captioned application, which led to the present case being opened as well as Case No. IM-2026-0079. For purposes of the present case, Stoutland requested that the Commission terminate Stoutland's Interconnected Voice over Internet Protocol (IVoIP) registration. Stoutland was granted an IVoIP registration in Case No. DA-2024-0288.

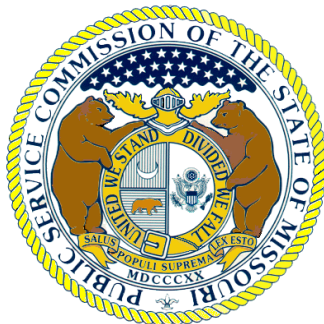
