On September 24, 2025,¹ Missouri-American Water Company (MAWC) filed applications seeking an order granting an expansion of its existing Certificates of Convenience and Necessity (CCNs). On October 2, MAWC filed its *Motion to Consolidate* (Motion), which stated that MAWC is the applicant in both cases, and in several locations

the water and sewer territories involved overlap. MAWC argued that the cases reference the same subject matter, will involve similar parties, and will contain common questions of law and fact, thus it requests they be consolidated with Case No. WA-2026-0075 as the lead case.

Commission Rule 20 CSR 4240-2.110(3) permits the consolidation of pending actions that involve related questions of law or fact. Since the cases will involve common facts, parties, and issues, the Commission will consolidate these cases.

THE COMMISSION ORDERS THAT:

- 1. MAWC's Motion is granted. Case Nos. WA-2026-0075 and SA-2026-0076 are consolidated, with Case No. WA-2026-0075 being the lead case.
 - 2. This order shall be effective when issued.
