VIDEO SERVICE AUTHORIZATION

On January 12, 2021, Cable One, Inc. d/b/a Sparklight ("the Company") pursuant to Section 67.2679.7, RSMo 2016, filed a Notice of Change Application to expand video service to additional political subdivisions and to provide notice of changes.

As part of an internal corporate reorganization, Sparklight's subsidiary, Telecommunications Managment, LLC d/b/a NewWave Communications, was merged with and into Sparklight effective December 31, 2020. Sparklight remains as the surviving entity, and NewWave Communications has ceased to exist. All customers served by NewWave Communications are now served by Sparklight effective January 1, 2021.

Pursuant to the Reorganization, Sparklight will now provide video service in the following political subdivisions, which were previously served by NewWave Communications pursuant to its Video Service Authorization:


