On January 20, 2021, Union Electric Company d/b/a Ameren Missouri filed a tariff. The tariff bears an effective date of February 19, 2021. According to Ameren Missouri, the tariff is consistent with the Unanimous Stipulation and Agreement that the Commission approved on July 29, 2020.

The Commission will order its Staff to file a Recommendation.

1. The Staff of the Commission shall file a Recommendation no later than February 1, 2021.
2. Any responses to the Recommendation shall be filed no later than February 3, 2021.
