## ORDER GRANTING MOTION TO MODIFY THE PROCEDURAL SCHEDULE

Issue Date: January 22, 2021

Effective Date: January 22, 2021

The Commission issued its order on January 6, 2021, establishing a procedural schedule in this case. That procedural schedule required the parties to file rebuttal testimony no later than January 22, 2021. Public Counsel (OPC) filed a motion to modify that procedural schedule on January 22, 2021. In support of its request, OPC states that, prior to the Commission issuance of the procedural schedule, a medical emergency prevented OPC from timely filing rebuttal testimony. OPC represents that, in light of those circumstances, the other parties have agreed to a modification of the procedural schedule as proposed by OPC.

The Commission will grant OPC's request.

### THE COMMISSION ORDERS THAT:

1. The remaining procedural schedule is modified to provide as follows:

February 5, 2021	Rebuttal testimony due. Response time to data request becomes 10 calendar days, with 3 business days to object after rebuttal testimony is filed.
February 19, 2021	Surrebuttal testimony due
February 23, 2021	Last day to request discovery
February 23, 2021	Parties file issues list, order of witnesses, and Order of cross-examination
February 26, 2021	Parties file position statements
March 11-12, 2021	Evidentiary hearing

April 8, 2021	Post-hearing briefs
April 16, 2021	Reply briefs

The additional procedural requirements contained in ordered paragraph three of the Commission's January 6, 2021, Order Establishing Procedural Schedule, Other Procedural Requirements, and Further Suspending Tariff Sheets, not specifically modified by this order, remain effective.
