## NOTICE OF ADMITTED AND FILED EXHIBITS

On December 4, 2020, the Commission conducted an evidentiary hearing in Claude Scott's complaint against Spire Missouri, Inc. d/b/a Spire. The hearing was conducted by telephone conference call, also accessible by video via Webex.

On December 10, 2020, the Commission issued a *Notice of Proposed Exhibits and Order Directing Filing of Objections*. The notice identified and attached a June 1, 2020 letter and an August 5, 2019 account statement and required objections to admission of such documents into the record to be filed no later than December 31, 2020. No such objections have been received. Adjudication staff marked the June 1, 2020 letter as Exhibit 103 and the August 5, 2019 account statement as Exhibit 106, and on January 22, 2021, the Commission's data center filed Exhibit 103 and Exhibit 106 in this case in the Commission's Electronic Filing and Information System.
