ORDER EXTENDING DEADLINE

On December 15, 2020, the Commission Staff (Staff) filed a Recommendation Regarding Summit Natural Gas of Missouri, Inc.'s 2018-2019 Actual Cost Adjustment Filing (Recommendation), and the Commission issued an Order Directing Filing requiring Summit Natural Gas of Missouri, Inc. (Summit) to file a response to Staff's recommendation no later than January 27, 2021. On January 25, 2021, Summit filed a Motion for Extension (Motion) requesting the deadline be extended to March 2, 2021. The Motion stated that after review of the recommendation and discussions with Staff, Summit believed further discussion would be beneficial to efficient processing and that Staff had no objection to the requested deadline extension. The Commission will grant the Motion.

THE COMMISSION ORDERS THAT:

1. Summit's Motion for Extension is granted.
2. No later than March 2, 2021, Summit shall file a response to Staff's Recommendation.
3. This order shall be effective when issued.
