**MOTION FOR LEAVE TO LATE FILE SCHEDULES**

Comes now Aquila, Inc., d/b/a Aquila Networks - L&P and Aquila Networks - MPS (“Aquila” or “Company”), by counsel, and for its Motion for Leave to Late File Schedules, respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. On January 26, 2004, Aquila filed, among other things, the Rebuttal Testimony of Joseph M. O’Donnell. At the time of filing, Aquila inadvertently neglected to file in EFIS the schedules referenced by Mr. O’Donnell’s testimony. Aquila therefore seeks to late file these schedules with the Commission.

2. Mr. O’Donnell’s schedules are attached hereto. Because surrebuttal testimony is not due until February 13, 2004, and the hearing in this matter is not scheduled to begin until February 23, 2004, Aquila believes that no party will be prejudiced by this request.

WHEREFORE, Aquila prays for an order granting its motion for leave to late file the attached schedules to the Rebuttal Testimony of Joseph M. O’Donnell.
