ORDER EXTENDING TIME TO RESPOND

On October 3, 2025,¹ Staff of the Commission (Staff) filed its investigative report. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. Spire Missouri Inc. d/b/a Spire's response is due October 14.

On October 7, Spire filed a *Request for Additional Time to Respond*. The *Request* explains that due to the length of Staff's investigation and report, Spire requests an extension for the filing of Spire's Response to November 14. The *Request* states that Staff has been advised of the requested extension and does not oppose it.

The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Spire's request for an extension is granted.
2. Spire's response to Staff's investigative report shall be filed no later than November 14, 2025.
3. This order shall be effective when issued.
