On October 6, 7, and 8, 2025, Complainant filed various versions of motions to quash a subpoena, motions to stay orders and subpoena, motions to quash Commission rulings, and for review before the full Commission.

On October 6, 2025, the Commission issued its *Order Granting Motion to Set Evidentiary Hearing and Denying Third Motion for Reconsideration of Motion to Quash, Motion to Stay/Suspend Proceedings, and Motion for Hearing on Motion Full Commission*. The Commission has already heard and addressed multiple Complainant's motions to quash the subpoena issued to Ameren Missouri, as well as his motions to stay the subpoena, attendant rulings, and motion hearing before the full Commission. Complainant has had ample opportunity to put forth his arguments on these issues. The Commission will address further motions requesting the same relief in its Report and Order.
