ORDER DIRECTING A FURTHER STATUS REPORT

The Staff of the Missouri Public Service Commission (Staff) filed a motion on July 21, 2020, requesting the Commission open a file for investigation of a natural gas pipeline incident in Kansas City, Missouri. Staff's motion explains the incident occurred on July 1, 2020, along Highway 169 in an area served by Spire Missouri West. The Commission opened this file and set January 25, 2021, as the deadline for Staff to either file a report regarding the incident or a report on the status of its investigation.

On January 25, 2021, Staff filed a status report stating that discovery concerning the incident is continuing. Staff requests until May 28, 2021, to file its report on the incident or to file a status report. The Commission finds that the request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff shall file its report on the incident or a further status report on or before May 28, 2021.
2. This order shall be effective when issued.
