ORDER GRANTING AUTHORITY TO CONTINUE SERVING AS AN INFORMATION AND REFERRAL PROVIDER

Issue Date: October 9, 2025 Effective Date: November 12, 2025

In Case No. AO-2004-0036, the Commission authorized United Way of Greater Kansas City, Inc. (United Way KC) to serve as a Missouri Information and Referral Provider for a period of three years. The Commission extended that authority in Case Nos. TO-2007-0338, AO-2011-0025, AO-2017-0059, AO-2020-0037, and AO-2023-0069. On August 11, 2025, United Way KC filed an application pursuant to Commission Rule 20 CSR 4240-28.015(2) for continuing authority as an Information and Referral Provider for purposes of 211 service. The Commission issued an order directing that notice be sent, set an intervention deadline, and directed the Staff of the Commission (Staff) to file a recommendation about the application. No intervention requests were received.

On September 22, 2025, Staff recommended that the Commission renew the authority of United Way KC as an Information and Referral Provider. No responses to Staff's recommendation were received.

The Commission has reviewed the application and Staff's recommendation and determines that the requested authority should be granted.

THE COMMISSION ORDERS THAT:

- 1. The United Way KC's application for continuing authorization to serve as a 211 Information and Referral Provider for the exchanges listed in its application is granted.
- 2. The authorization as a 211 Information and Referral Provider is granted for a period of three years.
 - 3. This order shall be effective on November 12, 2025.
 - 4. This case shall be closed on November 13, 2025.
