# ORDER DENYING COMPLAINANT'S DUE PROCESS MOTION TO RESTORE HIS DIRECT ACCESS TO THE COMMISSION'S ELECTRONIC FILING INFORMATION SYSTEM

Issue Date: October 9, 2025 Effective Date: October 9, 2025

On October 6, 2025, Complainant filed *Motion for Constitutional and Statutory Relief for Denial of Equal Access, Discriminatory Administrative Handling, and Due Process Violations*. Complainant requests relief from having to submit his pleadings for approval prior to being filed in the Commission's Electronic Filing Information System (EFIS). Complainant alleges that this practice deprives him of constitutional due process, equal protection, and right to petition. Complainant also alleges that the Regulatory Law Judge presiding over his case has exceeded his authority by requiring pre-approval of pleadings. Complainant has asked multiple times to have his direct filing access to EFIS restored. Those requests have been denied.

The Commission is not persuaded by Complainant's arguments. Complainant's ability to directly file pleadings in EFIS was restricted due to Complainant's continued abuse of EFIS when allowed to direct file. Complainant previously filed improper

pleadings that disparaged opposing parties and counsel, the Regulatory Law Judge, Commissioners, and administrative procedures. The Commission required Complainant to submit filings for review and approval prior to being filed in EFIS. The Regulatory Law Judge has rejected improper or duplicative filings. Proper pleadings have been filed in EFIS.

Complainant claims various due process violations. Complainant asserts that he is prevented equal access and timely participation in this proceeding. Complainant points to no specific instances where he was unable to file or respond to a proper pleading.

Prior to the Commission restricting his filings to those that are appropriate for administrative practice, Complainant would file an excessive number of improper pleadings, comments, and other irrelevant documents. Since his EFIS access has been restricted, Complainant has continued to make numerous filings, many of which are duplicative, argumentative, or otherwise improper. Given Complainant's continued efforts to exploit the Commission's electronic filing system, restoring his EFIS direct filing privileges is not appropriate.

The Commission will deny Complainant's motion to restore direct filing access to EFIS.

#### THE COMMISSION ORDERS THAT:

1. Complainant's Motion for Constitutional and Statutory Relief for Denial of Equal Access, Discriminatory Administrative Handling, and Due Process Violations is denied.
