On December 30, 2021, the Commission issued its Order Approving Second Disposition Agreement and Small Company Rate Increase (Order) granting Elm Hills Utility Operating Company, Inc.'s (Elm Hills) request for a water and sewer rate increase. The Order permitted Elm Hills to file compliance tariff sheets in compliance with the Second Disposition Agreement.

On January 28, 2021, Elm Hills filed its tariff sheets under Tariff No. YS-2021-0149 and YW-2021-0148. The effective date of the tariff sheets is February 27, 2021. The Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation as to whether the tariff sheets comply with the Commission's Order.

#### THE COMMISSION ORDERS THAT:

- 1. On or before February 11, 2021, Staff shall file a recommendation as directed in the body of this order.
- 2. Any other party wishing to file a recommendation regarding Elm Hills' compliance tariff sheets shall do so on or before February 11, 2021.
  - 3. This order shall be effective when issued.
