## ORDER EXTENDING TIME TO FILE COMMENTS

On September 27, 2020, Union Electric Company d/b/a Ameren Missouri filed its 2020 triennial integrated resource planning (IRP) compliance filing. Commission Rule 20 CSR 4240-22.080(7) provides that the Commission's Staff and other stakeholders are allowed 150 days in which to respond to that IRP filing. In this case, those responses would be due on March 1, 2021.

On January 28, 2021, Sierra Club filed a motion asking that the date for filing responses be extended by 14 days until March 15, 2021. The motion explains that the two week extension is necessary to allow the stakeholders sufficient time to review certain workpapers provided to the stakeholders by Ameren Missouri on January 20, 2021. The motion represents that all parties either support, or do not oppose the requested extension. Based on the motion's representation, the Commission will treat the requested extension as unopposed.

Commission Rule 20 CSR 4240-22.080(15) allows the Commission to modify the response periods regarding the IRP filing for good cause shown. The Commission finds that good cause has been shown to extend the time to respond by 14 days.

**THE COMMISSION ORDERS THAT:**

1. The reports of Staff and other stakeholders regarding Ameren Missouri's Integrated Resource Plan, previously due on March 1, 2021, shall now be filed no later than March 15, 2021.
2. This order shall be effective when issued.
