MOTION FOR WAIVER

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") on behalf of itself, and for its *Motion for Waiver*, respectfully states as follows:

- 1. On April 21, 2025, Environmental Utilities, LLC, d/b/a Golden Glade Water System ("EU"), filed a letter with the Missouri Public Service Commission ("Commission"), requesting a rate increase initiating a small utility rate case under Commission Rule 20 CSR 4240-10.75.
- 2. Commission Rule 20 CSR 4240-10.75(11)(A) states that at the 150th day in the small rate case timeline, Staff is required to make a filing with the Commission. Said filing is required to be either a). a disposition agreement between Staff and the utility that fully resolves the small utility rate case, b). a disposition agreement between Staff and the utility that partially resolves the small utility rate case and a motion requesting that the case proceed to hearing, or c). a motion stating to the Commission that an agreement cannot be reached on any of the issues and asking the Commission to hear the case.
- 3. On September 17, 2025, Staff filed a *Notice of Rate Case Timeline Extension*, pursuant to Commission Rule 20 CSR 4240-10.075(5)(A), extending the timeline by 30 days. This extension moved the 150th day from September 18, 2025, to October 17, 2025.

4. Pursuant to Commission Rules 20 CSR 4240-2.205 and 10.075(15), Staff respectfully requests a waiver of timeline in the above case. Staff believes that good cause exists because the parties have not yet reached a resolution.

5. Staff will file a procedural schedule or status report no later than October 31, 2025.

WHEREFORE, Staff submits this *Motion for Waiver* for the Commission's consideration and prays the Commission grant the requested waiver, as well as further relief as is just and proper.
