### ORDER SHORTENING TIME TO RESPOND TO MOTION

On April 21, 2025,<sup>1</sup> Environmental Utilities, LLC filed a letter requesting an increase in its annual water system operating revenues. On April 25, the Staff of the Commission (Staff) filed a *Small Utility Rate Case Timeline* pursuant to the staff assisted rate case procedure under Commission Rule 20 CSR 4240-10.075.

On September 17, Staff filed its *Notice of Rate Case Timeline Extension*, as allowed by Commission Rule 20 CSR 4240-10.075(5)(A), extending the 150-day deadline to file a disposition agreement or request for a hearing<sup>2</sup> to October 17.

On October 17, Staff filed a *Motion for Waiver*, requesting a waiver for good cause of the October 17<sup>th</sup> deadline pursuant to Commission Rule 20 CSR 4240-10.075(15) and stating their intention to file a procedural schedule or status report by October 31.

The Commission will shorten the time period for responses to Staff's motion.

#### THE COMMISSION ORDERS THAT:

- 1. Any party wishing to respond to Staff's *Motion for Waiver* shall do so no later than October 22, 2025.
  - 2. This order shall be effective when issued.
