MOTION TO CANCEL REGISTRATION OF OPERATING CERTIFICATE

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”) and moves for the Missouri Public Service Commission (“Commission”) to cancel the certificate to provide interexchange telecommunications and non-switched local exchange (IXC) service in Missouri of Prime Line Communications d/b/a Prime Link Long Distance, Inc. (“Company”) and states:

1. On March 28, 1997, the Commission granted a certificate of authority to provide IXC service in Case No. TA-97-320, to the Company.
2. On March 13, 2025, the Company notified the Commission that it no longer wished to retain its operating certificate to provide IXC services in Missouri in an indication on its Statement of Revenue, BSOR-2025-0567, filed for calendar year 2024.
3. Pursuant to 20 CSR 4240-28.011(3), a company may cancel a certificate of service authority or registration by filing a letter signed by the company’s official that identifies when and which certificate, registration, and any applicable tariff to cancel. The Rule states the letter should be electronically filed in the Commission’s Electronic Filing and Information System (“EFIS”).
4. The company properly submitted notice to the Commission requesting cancellation of its authority to provide IXC services in Missouri. An officer of the Company, Owner Chester White, signed the statement requesting cancellation of the company’s certificate, and the Company filed the statement in EFIS. The Company does not have a currently effective tariff.

5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommend the Commission cancel Prime Line Communications d/b/a Prime Link Long Distance, Inc.'s certificate of authority to provide IXC service in Missouri.
