**NOTICE OF EX PARTE CONTACT
AND CLARIFICATION OF CASE STATUS**

Issue Date: February 3, 2021

On February 3, 2021, information was provided to the Commission that Claude Scott had contacted the Commission’s data center by phone regarding this case. The presiding officer was notified that Mr. Scott stated he had not agreed to a February 19, 2021 hearing date. This notice is given to place this communication in the file and notify all parties, as required by Commission Rule 20 CSR 4240-4.020(3).

This case was scheduled for evidentiary hearing on January 15, 2021. On January 14, 2021, Mr. Scott requested the hearing be rescheduled to February 8, 2021. Mr. Scott’s request was submitted by e-mail message to counsel for the Staff of the Commission. On January 14, 2021, the Commission granted the continuance request in an order that stated that the February 8 date was not available on the Commission’s calendar. The Commission directed the parties to propose available dates for hearing. A pleading filed by Staff on January 22, 2021, indicated all parties agreed to a February 19, 2021 hearing. Based on that pleading, the Commission scheduled an evidentiary hearing in this case on February 19, 2021.

At this time, this case is scheduled for evidentiary hearing on February 19, 2021, and no motions are now pending to reschedule the hearing.


