# ORDER GRANTING LIMITED INTERVENTION

Issue Date: October 23, 2025 Effective Date: October 23, 2025

On October 10, 2025, Complainant's wife, Lisa Lambert, requested that the Commission grant her intervention because she and Complainant jointly own a bank account that Union Electric Company d/b/a Ameren Missouri seeks to obtain information about. Ten days have elapsed, and no party has objected to the application to intervene.<sup>1</sup>

Commission Rule 20 CSR 4240-2.075(9) permits the Commission to limit interventions to particular issues or interests in a case. The Commission will grant intervention to Lisa Lambert, but will strictly limit her intervention to the subpoena of, and discoverability of, the joint bank account records.
