A. The purpose of Rider SR was to implement the solar rebates established by §393.1030 and §393.1670 RSMo, which contain requirements for electrical corporations to make solar rebates available to customers. However, the requirements in §393.1030 to make solar rebates available to customers ended June 30, 2020,¹ and the requirements in §393.1670 only required Empire to pay rebates in an aggregate amount of seven million dollars.² As of October 30, 2022, Empire had exceeded the seven-million-dollar aggregate requirement by over one million dollars,³ and has since not been subject to the requirements in §393.1670, RSMo. Additionally, in Case No. ET-2023-0197, Empire requested approval to revise its Rider SR and discontinue the payment of rebates under the solar rebate program. This request was approved by the Commission with an effective date of May 20, 2023.⁴

- Q. Please summarize Staff's recommendation.
- A. Staff recommends that compliance tariffs resulting from this case remove Rider SR, P.S.C. Mo. No. 6, Sec. 4, Original Sheet 23 to 23h.
 - Q. Does this conclude your direct testimony?
