ORDER SETTING DEADLINE FOR RESPONSES

On September 15, 2025,¹ the Staff of the Commission (Staff) filed its *Staff Recommendation* regarding the application of Ameren Transmission Company of Illinois (ATXI) in this matter.

On October 24, the Office of the Public Counsel (Public Counsel) filed its *Response to Staff Recommendation* in which it requested the Commission impose two additional conditions on approval of ATXI's application.

Subsequent to Public Counsel's filing, on October 24, ATXI filed a *Motion for Leave to File Response to Office of Public Counsel's Request for Conditions*, requesting the Commission grant it until October 31 to respond to Public Counsel's *Response to Staff Recommendation*.

The Commission finds Public Counsel's motion reasonable and will grant it, but, rather than setting October 31st as the deadline for ATXI to respond, the Commission will allow all parties ten days to respond.

1. Any party wishing to respond to Public Counsel's *Response to Staff Recommendation* may do so no later than November 3, 2025.
