The Commission will give notice of the application, and it will further allow an opportunity for interested parties to apply for intervention.

3. Applications to intervene shall be filed no later than November 12, 2025.
4. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than December 15, 2025.
