On October 22, 2025, Assurance Wireless USA, L.P. applied for expanded designation as an Eligible Telecommunications Carrier (ETC) in the state of Missouri. Assurance Wireless stated that it seeks to expand its designated service area to statewide authority – specifically to include the wire centers listed in Exhibit 1 attached to the application.

Notice of the application shall be sent to all ETCs certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and will direct the filing of a recommendation by the Staff of the Commission (Staff).

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all eligible telecommunications carriers certificated to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than November 12, 2025. Such applications shall be filed with:
