STAFF RECOMMENDATION TO APPROVE TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by Missouri-American Water Company (“MAWC”) states the following:

1. On September 10, 2025, the Commission issued its *Order Authorizing Purchase and Granting Certificate of Convenience and Necessity*. The *Order* directed MAWC to file compliance tariff sheets.
2. On October 14, 2025, MAWC filed its proposed tariff revision, Tracking No. JW-2026-0053, bearing an effective date of November 13, 2025.
3. On October 15, 2025, the Commission issued its *Order Directing Staff Compliance Recommendation*. The *Order* directed Staff to file a recommendation regarding whether the tariff sheets comply with the Commission’s September 10, 2025 Order no later than October 30, 2025.
4. Staff has reviewed the tariff sheet submitted by MAWC and recommends its approval.

WHEREFORE, Staff respectfully submits this Staff Recommendation to Approve Tariff, and respectfully requests the Commission approve the tariffs filed by MAWC.

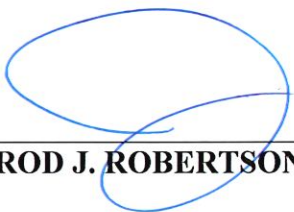

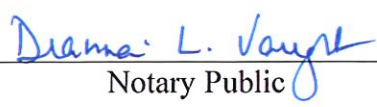
