NOTICE OF PROPOSED TRANSFER OF STOCK OF OREGON FARMERS MUTUAL TELEPHONE

Dear Oregon Farmers' Customer:

On March 9, 2004, Oregon Farmers Mutual Telephone Company (Oregon Farmers) and Northwest Missouri Holdings, Inc. (Northwest Missouri Holdings) filed a Joint Application with the Missouri Public Service Commission for approval of a Stock Purchase Agreement which provides for the Sale and Transfer of the Stock of Oregon Farmers to Northwest Missouri Holdings. The Commission has docketed this matter as Case No. IM-2004-0461. The purpose of this notice is to advise you, as an Oregon Farmers' customer, of this proceeding.

Under the terms of the Stock Purchase Agreement, all outstanding shares of Oregon Farmers would be transferred to Northwest Missouri Holdings, a Delaware Corporation authorized to do business in Missouri.
