## STAFF RECOMMENDATION TO APPROVE TARIFF SHEET

**COMES NOW** the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and for its *Recommendation to Approve Tariff Sheet* states as follows:

1. On October 1, 2010, The Empire District Electric Company ("Empire") filed a tariff sheet bearing a proposed effective date of December 1, 2010, to revise its Cost Adjustment Factors (CAF) of its Fuel Adjustment Clause (FAC). The filing was pursuant to the Commission's *Reports and Orders* in Case Nos. ER-2008-0093, authorizing Empire's FAC, and ER-2010-0130, authorizing Empire's continued use of an FAC.

2. Commission Rule 4 CSR 240-20.090(4) provides that the Staff "shall submit a recommendation regarding its examination and analysis to the Commission not later than thirty (30) days after the electric utility files its tariff schedules to adjust its FAC rates." Staff must determine if Empire's proposed adjustment to the FAC is in accordance with 4 CSR 240-20.090, §386.266 RSMo, and the "FAC mechanism established in the most recent general rate proceeding." *Id.* 

3. Commission Rule 4 CSR 240-20.090(4) provides in part:

[T]he commission shall either issue an interim rate adjustment order approving the tariff schedules and the FAC rate adjustments within sixty (60) days of the electric utility's filing or, if no such order is issued, the tariff schedules and the FAC rate adjustments shall take effect sixty (60) days after the tariff schedules were filed.

4. In the attached Memorandum (Appendix A), the Staff recommends that the Commission issue an interim rate adjustment to either allow the tariff sheet to become effective by operation of law, or enter an order approving Empire's Tariff Sheet, P.S.C. MO. No. 5, 5<sup>th</sup> Revised Sheet No. 17c Cancelling 4<sup>th</sup> Revised Sheet No. 17c, as filed on October 1, 2010, to become effective December 1, 2010, subject to true-up and prudence reviews.

5. The Staff's review shows Empire's filing is in compliance with §386.266 RSMo, 4 CSR 240-20.090, and the Case Nos. ER-2008-0093 and ER-2010-0130 *Reports and Orders*.

**WHEREFORE,** the Staff recommends that the Commission either allow to become effective by operation of law, or issue an interim rate adjustment Order approving, Empire's Tariff Sheet, P.S.C. MO. No. 5, 5<sup>th</sup> Revised Sheet No. 17c Cancelling 4<sup>th</sup> Revised Sheet No. 17c, as filed on October 1, 2010, to become effective December 1, 2010, subject to true-up and prudence reviews.
