ORDER DIRECTING FILING

On January 15, 2021, Liberty Utilities (Missouri Water) LLC ("Liberty Water") submitted an application requesting authority to issue additional long-term unsecured debt and to incur, pay, and amortize the debt issuance expense and/or a proportional share of fees associated with the debt.

The Commission ordered its Staff to file, no later than February 9, 2021, a recommendation or a status report indicating when it expects to file a recommendation. Staff filed a status report on February 9, 2021, and advised it continues to gather information about the case and expects to receive Liberty Water's response to a pending data request no later than February 25, 2021. Staff states it expects to be able to file a recommendation no later than March 1, 2021.

The Commission will order Staff's recommendation consistent with Staff's status report.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Liberty Water's application no later than March 1, 2021.

2. This order shall be effective when issued.


