On November 16, 2021, the Commission directed the Commission's Staff (Staff) to file a Recommendation on the Applications of Liberty Utilities (Missouri Water) LLC, d/b/a Liberty Utilities for Certificates of Convenience and Necessity no later than February 15, 2021. On February 8, 2021, the Staff filed a request that the deadline be extended sixty days to no later than April 16, 2021. Staff explained that it is continuing to issue data requests to help its review, continuing to provide feedback to Liberty, and continuing its discussions with Liberty. Staff explained it needed the additional time to accommodate further analysis and discussions. The Commission will grant the Motion for Extension.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file its recommendation on the Applications no later than April 16, 2021.
