ORDER REGARDING EXHIBITS

On January 28, 2021, during the hearing in this matter Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively referred to as "Evergy") and the Office of the Public Counsel (Public Counsel) were directed to file tariff sheets which they believed were effective during the relevant fuel adjustment clause period so that the Commission could take administrative notice of those tariff sheets. Evergy and Public Counsel each filed tariff sheets. Evergy's tariff sheets have been marked for identification as Exhibits 11 and 12 and Public Counsel's tariff sheets have been marked as Exhibit 204.

Additionally, Evergy filed Exhibit 13 -- File Nos. EO-2020-0227 and EO-2020-0228 Staff Data Request 42 and Exhibit 14 -- SPP Load Ratio Shares. The parties were directed to file any objections to the Commission taking administrative notice of the tariff sheets and any objections to the admission of Exhibits 13 and 14, no later than February 4, 2021. Objections and responses were received from Public Counsel and Evergy.

Exhibits 11 and Exhibit 12 purport to be demand response program tariff sheets for the company effective during the relevant period. However, the tariff sheets submitted

are not the same as the tariff sheets in the Commission’s Electronic Filing and Information System (EFIS). Some of the official tariff sheets as found in EFIS were canceled prior to the prudence review period at issue and some had different effective dates than those presented in Evergy’s version. Therefore, the Commission will not take official notice of Exhibits 11 and 12.

The Commission has reviewed the filings and objections and takes official notice of the tariff sheets on file with the Commission as submitted by Public Counsel and set out below. Any objections to Exhibit 204 are overruled. Any objections to Exhibits 11 and 12 are sustained.

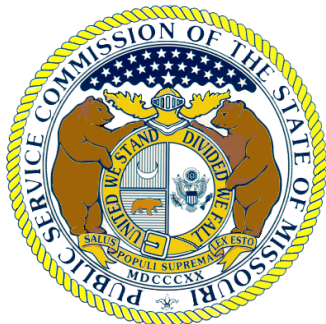


