ORDER APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: February 16, 2021

Effective Date: February 27, 2021

On December 30, 2020, the Commission issued its *Order Approving Second Disposition Agreement and Small Company Rate Increase* (Order) granting Elm Hills Utility Operating Company, Inc.'s (Elm Hills) request for a water and sewer rate increase. The Order permitted Elm Hills to file tariff sheets in compliance with the terms of the Order.

On January 28, 2021, Elm Hills filed compliance tariff sheets under Tariff Nos. YS-2021-0149 and YW-2021-0148.¹ The effective date of the tariff sheets is February 27, 2021. An expedited review by the Staff of the Missouri Public Service Commission (Staff) was ordered, and on February 10, 2021, Staff filed its recommendation that the tariff sheets be approved. The Commission allowed for the filing of any responses to the proposed tariff sheets. No responses or objections were received, thus the Commission will take up Elm Hills's compliance tariff sheets unopposed.

Upon reviewing the pleadings, the Commission finds Elm Hills's proposed tariff sheets comply with the Commission's Order and will approve them. To accommodate Elm Hills's chosen tariff effective date, the Commission will make this order effective in

less than thirty days and will approve the proposed tariff sheets to become effective on February 27, 2021.

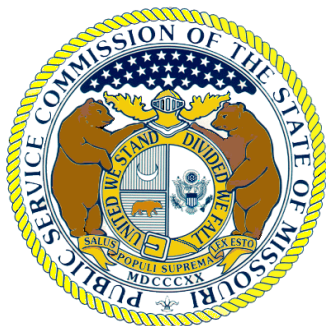
