On January 5, 2021, Conexon Connect, LLC filed its application for designation as a wireless Eligible Telecommunications Carrier. Commission Rule 20 CSR 4240-4.017(1) requires applicants to file a notice with the Commission 60 days prior to filing such an application. Commission Rule 20 CSR 4240-4.017(1)(D) allows a party to request waiver of this rule for good cause.¹

The Commission will order Conexon Connect to show compliance with the aforementioned rule, or to request a waiver thereof.

THE COMMISSION ORDERS THAT:

1. Conexon Connect shall respond as ordered above no later than February 26, 2021.
2. This order shall be effective when issued.


