On January 5, 2021, Co-Mo Comm. Inc. d/b/a Co-Mo Connect filed its application for expansion of its designation as a wireless Eligible Telecommunications Carrier. Commission Rule 20 CSR 4240-4.017(1) requires applicants to file a notice with the Commission 60 days prior to filing such an application. Commission Rule 20 CSR 4240-4.017(1)(D) allows a party to request waiver of this rule for good cause.¹

The Commission will order Co-Mo Connect to show compliance with the aforementioned rule, or to request a waiver thereof.

THE COMMISSION ORDERS THAT:

1. Co-Mo Connect shall respond as ordered above no later than February 26, 2021.
2. This order shall be effective when issued.

¹ Per Commission Rule 20 CSR 4240-4.017(1)(D), good cause for waiver may include, among other things, a verified declaration from the filing party that it has had no communication with the office of the commission within the prior one hundred fifty (150) days regarding any substantive issue likely to be in the case.

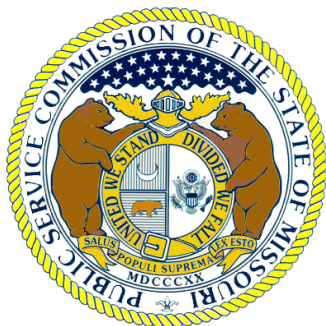
