**ORDER APPROVING TARIFFS FILED IN COMPLIANCE WITH**  
**COMMISSION ORDER**

On April 13, 2004, the Missouri Public Service Commission issued its Order Approving Stipulation and Agreement in this case, authorizing Aquila, Inc. d/b/a Aquila Networks – MPS and Aquila, Inc. d/b/a Aquila Networks – L&P to file proposed tariff sheets in compliance with the Commission's order. The order directed Aquila to file tariff sheets with an effective date of April 22, 2004.

The Staff of the Commission reviewed the tariff sheets and filed a memorandum on April 16, 2004. Staff recommends that the Commission approve the Company's tariff sheets to become effective on April 22, 2004. Section 393.140(11), RSMo 2000, requires that proposed changes to tariffs not go into effect with less than 30 days' notice, unless otherwise ordered by the Commission. The Unanimous Stipulation and Agreement was filed with the illustrative tariff sheets on March 16, 2004. And, as ordered by the Commission, the tariffs bear an effective date of April 22, 2004. Based on these facts, Staff states that the purpose of Section 393.140(11) has been served.

The Commission has reviewed the tariffs and Staff's recommendation and finds that the tariff sheets conform to the Unanimous Stipulation and Agreement approved by the

Commission on April 13, 2004, and should be approved. The tariffs will become effective on April 22, 2004.

**IT IS THEREFORE ORDERED:**

1. That the tariff filed by Aquila, Inc., and assigned tariff number YE-2004-1257, is approved to become effective on April 22, 2004. The tariff approved is:

**Aquila Networks, P.S.C. Mo. No. 1, Schedule of Electric Rates**

2. That the tariff filed by Aquila, Inc., and assigned tariff number YH-2004-1260, is approved to become effective on April 22, 2004. The tariff approved is:

**Aquila Networks, P.S.C. Mo. No. 1, Schedule of Steam Rates**

3. That the following electric and steam tariffs are cancelled:

- Aquila Networks – L&P, P.S.C. MO. No. 6**
- Aquila Networks – MPS, P.S.C. MO. No. 2**
- Aquila Networks – L&P, P.S.C. MO. No. 3**

4. That this order shall become effective on April 22, 2004.
