ORDER RECOGNIZING NAME CHANGE

Issue Date: February 18, 2021

Effective Date: March 5, 2021

Spectrotel, Inc. d/b/a Touch Base Communications submitted a letter on February 3, 2021, advising that it has changed its name to Spectrotel of the Midwest LLC d/b/a Touch Base Communications. Along with its letter, the company submitted a revised tariff to incorporate its new name. That tariff was assigned Tariff Tracking No. YL-2021-0157, and is set to become effective on March 5, 2021. On February 18, 2021, the Commission's Staff (Staff) filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

The tariff will be allowed to take effect on March 5, 2021 by operation of law. This order will be made effective on March 5, 2021, to match the effective date of the tariff.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes Spectrotel, Inc. d/b/a Touch Base Communications' name change to Spectrotel of the Midwest LLC d/b/a Touch Base Communications.
2. This order shall be effective on March 5, 2021.

3. This file shall be closed on March 6, 2021.

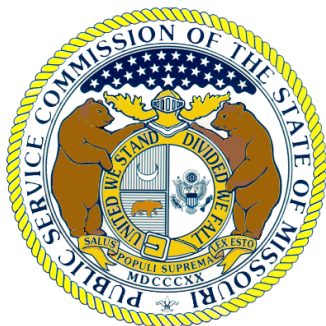
