### ORDER DIRECTING EXPEDITED RESPONSE

On January 18, 2021, Spire Missouri Inc. filed a motion to modify the Commission's December 2, 2020 *Order Modifying Temporary Waiver and Directing Written Notice*. Spire requested the Commission extend the period of waiver from March 31 to October 31, 2021. In addition, Spire requested the Commission remove a one-year limit on noncompliance for any location, which is required as a condition of waiver by the Commission's June 11, 2020 *Order Approving Application for Temporary Waiver and Directing Written Notice*. Spire's motion requested expedited treatment.

On February 19, 2021, Staff filed a recommendation that the Commission grant the request, in part, with specified conditions.

To facilitate expedited review of Spire's motion, the Commission will direct Spire to respond to Staff's recommendation and will establish deadlines for response from any other party and for any reply.

#### THE COMMISSION ORDERS THAT:

1. No later than February 24, 2021, Spire shall file a response to *Staff Recommendation*, as described above.

- 2. Response to *Staff Recommendation* from any other party shall be filed no later than February 24, 2021.
- 3. Any reply to responses to *Staff Recommendation* shall be filed no later than 3 p.m. February 26, 2021.
  - 4. This order shall be effective when issued.
