## JOINT SUGGESTED VENUE FOR IN-PERSON LOCAL PUBLIC HEARING

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company"), by and through undersigned counsel, on behalf of itself; Staff of the Missouri Public Service Commission ("Staff"); the Office of Public Counsel ("OPC"), Renew Missouri Advocates d/b/a Renew Missouri ("Renew"); and Sierra Club (collectively, the "Parties"), and for this *Joint Suggested Venue for In-Person Local Public Hearing* respectfully states as follows:

- 1. On October 28, 2025, in accordance with the Missouri Public Service Commission's ("Commission") orders issued on October 3<sup>rd</sup> and 15<sup>th</sup>, the Parties submitted a *Proposed Procedural Schedule*, in this matter. The Parties noted they would file a suggested venue for the in-person local public hearing by November 4, 2025.
- 2. The Parties respectfully suggest the City of Fulton Legends Rec Plex since an activity room is available on January 7, 2026, at 6 p.m. The City of Fulton Legends Rec Plex is located at 808 State St., Fulton Missouri, 65251.
- 3. Additionally, Ameren Missouri respectfully requests to the Commission direct the Company to send out customer text or email notifications regarding the hearing on December 18, 2025, to avoid sending customer notifications over the holidays. The Company also respectfully requests the Commission issue an order no later than

November 10, 2025, to allow sufficient time for the Company to prepare for sending out customer notifications regarding the local public hearings.

WHEREFORE, Ameren Missouri respectfully submits the suggested venue for the local public hearing at the City of Fulton Legends Rec Plex, and respectfully requests the Commission issue an order establishing a procedural schedule and procedural requirements, including text or email the customer notification on December 18, 2025, in accordance with the October 28, 2025 filing and this filing.
