STAFF'S MOTION TO EXTEND DATE BY WHICH AMEREN MISSOURI IS REQUIRED TO FILE A NEW ELECTRIC RATE SCHEDULE COMBINING ITS TWO TARIFF SCHEDULES INTO ONE TARIFF SCHEDULE AND REQUEST FOR EXPEDITED TREATMENT

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Motion for to Extend Date By Which Ameren Missouri is* Required to File a New Electric Rate Schedule Combining its Two Tariff Schedules into One Tariff Schedule and Request for Expedited Treatment, states as follows:

- 1. On September 28, 2012, Ameren Missouri and the Staff entered into a Nonunanimous Stipulation and Agreement Regarding Certain Revenue Requirement Issues ("Stipulation").
- 2. Paragraph 5 of the *Stipulation* provided, "The Company agrees to file a new electric rate schedule that combines its two tariff schedules as one tariff schedule by January 31, 2013."
- 3. No party objected to the *Stipulation* and the Commission deemed it to be a unanimous stipulation and agreement and approved it by order issued on October 10, 2012, effective October 20, 2012. The Commission ordered the signatory parties to comply with the terms of the *Stipulation*.
- 4. The Staff has requested that Ameren Missouri delay the aforementioned tariff filing because it is not able to review the same within 30 days of January 31, 2013, due to the press of other business. A careful review of a restated tariff is necessary to ensure that all of the provisions are accurate and complete.

- 5. Ameren Missouri has advised Staff that it would be willing to make the required filing on June 1, 2013, effective July 1, 2013.
- 6. Ameren Missouri has authorized Staff to state herein that the Company does not oppose this request.
- 7. Staff further prays that the Commission will take up and determine this motion on an expedited basis so that the Company will not be in the position of violating the Commission's order of October 10, 2012.

WHEREFORE, Staff prays that the Commission will, on an expedited basis, grant an extension of time such that Ameren Missouri may file its restated and combined tariff on June 1, 2013, with an effective date of July 1, 2013, instead of by January 31, 2013, as previously ordered.
