ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 4, 2025, Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment factors and Actual Cost Adjustment (ACA) factors. The tariff sheets have been assigned Tracking No. JG-2026-0066 and bear an effective date of December 1, 2025.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding the tariff sheets on an expedited basis. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than November 19, 2025, Staff shall file a recommendation with regard to Tracking No. JG-2026-0066.
2. Any other entity wanting to comment on the tariff sheets shall do so no later than November 19, 2025.

3. This order shall be effective when issued.

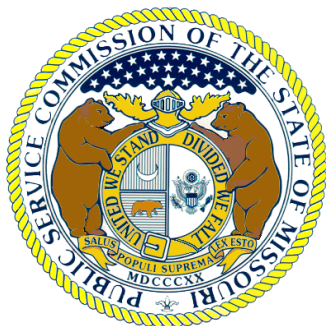
