ORDER SETTING LOCAL PUBLIC HEARING

On October 27, 2025,¹ the Staff of the Commission (Staff) filed a *Request for Local Public Hearing* (Request) requesting an in-person local public hearing be scheduled between the dates of December 8, 9, 10, 11, 15, 16, or 17 in or around the city of Neosho, Missouri. The Request states that Staff contacted Missouri-American Water Company (MAWC) and the Office of the Public Counsel (OPC) to confirm the parties' availability on those dates. On October 31, MAWC filed its *Response to Staff's Request for Local Public Hearing* (Response). The Response confirmed MAWC's availability on December 8, 15, 16, or 17 but explained that the mayor of Neosho would not be available on December 15, 16, or 17. The Response requested that the local public hearing be scheduled on December 8 to accommodate the conflicting schedules.

The Commission will schedule a local public hearing for December 8, 2025 in-person and will direct written comments be submitted to the Commission's Electronic Filing and Information System (EFIS).

 Neosho, Missouri 64850 to begin at 6 p.m. on December 8, 2025.
- 2. The public hearing will begin with a question-and-answer session and formal public comments to the Commission will begin immediately following the conclusion of the question-and-answer session.
- 3. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

- 5. Written comments may be submitted to the Commission in writing by mailing the comment to the Missouri Public Service Commission, P.O.
