ORDER GRANTING STAFF'S MOTION TO CORRECT TRANSCRIPT

On July 11, 2022, the Staff of the Commission submitted a motion asking the Commission to correct a line of the transcript by completing an answer that was marked by the court reporter as "inaudible". The Commission ordered that any party wishing to respond to Staff's motion do so by July 12, 2022. No party has filed a response.

Commission Rule 20 CSR 4240-2.110(7) allows for the correction of a transcript upon the motion of a party. Staff has demonstrated that the transcript should be corrected and no party objects to that correction. The Commission will grant Staff's motion.

THE COMMISSION ORDERS THAT:

1. Volume 7, Page 587, lines 8 through 13, of the transcript are corrected to provide as follows (corrected language in bold):

Judge Woodruff: Does a single financing order or two separate financing orders provide a benefit or detriment during the bond issuance process all else being equal?

The Witness: All else being equal a single financing order would **provide a benefit**.

2. This order shall be effective when issued.
