ORDER GRANTING APPLICATIONS TO INTERVENE

On November 2, 2021,¹ Evergy Missouri West (EMW) filed an application asking the Commission to approve a Special High Load Factor Market rate. The Commission provided notice of a technical conference, conducted by EMW, occurring on November 10 and encouraged early application for intervention to accommodate the technical conference.

Prior to the technical conference, Velvet Tech Services, LLC, Google LLC, and Midwest Energy Consumers Group (MECG) submitted applications to intervene. The Commission ordered expedited responses to the intervention applications, but no responses or objections were received.

After considering the unopposed applications to intervene, the Commission finds that the intervener applicants have interests which are different from that of the general public and allowing them to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the applications to intervene.
