AMENDED ORDER DIRECTING NOTICE AND ESTABLISHING INTERVENTION DATE

Issue Date: October 5, 2021 Effective Date: October 5, 2021

On September 15, 2021, the Empire District Electric Company d/b/a Liberty filed tariff sheets and an application seeking the Commission's approval to establish a Demand Side Investment Mechanism (DSIM). Liberty's tariff sheets bear a November 14, 2021, effective date, and Liberty asks that its application be approved to be effective by that date. The tariff sheets include projected program costs and projected throughput disincentives associated with its Missouri Energy Efficiency Investment Act Cycle 1 programs. Commission Rule 20 CSR 4240-20.094(4)(H), requires the Commission to approve, approve with modification acceptable to the electric utility, or reject the DSIM application within 120 days of the filling.¹

Liberty's application also contains a request for a waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(1).

The Commission will establish a deadline for the filing of applications to intervene, direct its Staff to file a date certain that it can submit a recommendation on Liberty's application, and direct its Data Center to serve a copy of this order upon the county

commission of each county in Liberty's service area. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving Liberty's service area and to the members of the Missouri General Assembly representing the residents of Liberty's service area.

THE COMMISSION ORDERS THAT:

- 1. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than October 12, 2021.
- 2. The Commission's Data Center shall provide a copy of this order to the county commission of each county in Liberty's service area.
- 3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of Liberty's service area and to the news media serving the residents of Liberty's service area.
- 4. The Commission's Staff shall file a pleading no later than October 15, 2021, stating the date that it will submit a recommendation.
 - 5. This order is effective when issued.
