**ORDER DIRECTING A STAFF TARIFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On May 1, 2023, The Empire District Electric Company d/b/a Liberty filed tariff sheets that will take effect on July 1, 2022. Liberty asserts that those tariff sheets adjust for an over-recovery during the first year of Liberty’s Missouri Energy Efficiency Investment Act Cycle 1. So the Commission can evaluate whether to approve Liberty’s tariff sheets, the Commission will direct its Staff to analyze the tariff sheets and file a recommendation. The Commission will also set a deadline for any responses to Liberty’s tariff sheets or Staff’s recommendation.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Liberty’s tariff sheets, or request additional time, no later than May 23, 2023.
2. Any responses to Liberty’s tariff sheets or Staff’s recommendation must be filed no later than June 6, 2023.
3. This order is effective when issued.
