The Office of the Public Counsel (Public Counsel) filed a motion on March 14, 2022, expressing concern that Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) has informed stakeholders that it intends to rely on data from its 2019 market potential study rather than its 2022 market potential study to support its 2024-2026 MEEIA application. Public Counsel asks the Commission to either order Ameren Missouri to use its 2022 market potential study to support its 2024-2026 MEEIA application, or to provide written or verbal affirmation that the Commission agrees with Public Counsel's concerns.

Before taking any action in response to Public Counsel's motion, the Commission will direct Ameren Missouri and the Commission's Staff (Staff) to respond.

1. Ameren Missouri and Staff shall respond to Public Counsel's *Motion for Commission Order* no later than March 29, 2022.

2. Any other party wishing to respond to Public Counsel's *Motion for Commission Order* shall do so no later than March 29, 2022.
