**ORDER GRANTING REQUEST FOR EXTENSION OF TIME**

On October 8, 2021, Evergy Metro, Inc., d/b/a Evergy Missouri Metro, submitted an Application and Request for Variance to the Commission (Application). Evergy Missouri Metro wants to sell certain of its assets located in Carroll County, Missouri, to Show Me Ethanol, LLC, a customer of Evergy Missouri Metro.

On October 18, 2021, the Commission directed the Staff of the Commission (Staff) to file a recommendation, or a status report indicating when it will file its recommendation, regarding the Application no later than November 18, 2021.

On November 17, 2021, Staff filed a *Motion for Additional Time*, requesting that the deadline to file a recommendation be moved to no later than December 16, 2021. Staff stated that information regarding the proposed transaction that was received on November 15 and 16 is still under review and that additional information is due on November 21, 2021. Evergy Missouri Metro does not oppose Staff's motion.

The Commission finds the motion reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Staff's motion for additional time to file its recommendation is granted. Staff shall file its recommendation as soon as possible, but no later than December 16, 2021.

2. This Order shall be effective when issued.
