ORDER GRANTING ADDITIONAL TIME

On March 21, 2022, the Commission issued an *Order Adding Party and Directing Responses to Application* in which it made The Empire District Electric Company d/b/a Liberty a party to the proceeding. The order also directed Liberty to file a response to the application by April 20, 2022, and directed the Staff of the Commission (Staff) to file a recommendation regarding the application or a status report by May 5, 2022.

On April 20, 2022, Liberty filed its *Response to Application and Order Directing Filing*. In its response, Liberty stated that it has engaged in discussions with White River Valley Electric Cooperative, Inc. (White River) and “will be able to reach an amicable resolution that serves the public interest.” Liberty requested a 30 day extension of time to work with White River to reach a settlement agreement and a 30 day extension of time for Staff to file a recommendation or a status report.

The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. Liberty is granted an extension of time to file a response to the application and shall do so no later than May 20, 2022.

2. Staff shall file its recommendation regarding the application no later than June 3, 2022, or provide to the Commission by that date a status report as to when it expects to file its recommendation.

3. This order is effective when issued.
