#### ORDER REGARDING LATE-FILED EXHIBITS AND OBJECTIONS

Issue Date: November 12, 2025 Effective Date: November 12, 2025

On October 27, 2025,<sup>1</sup> the Commission ordered late-filed exhibits be filed no later than October 31 and objections to those exhibits be filed no later than November 5. On October 28, McGinley-Krawczyk Farms filed exhibits 952C<sup>2</sup> and MS-7C<sup>3</sup>. On October 29, Mr. Harding filed exhibits 812, 813, 820P, 825P, 825C, 826, 828P, 829, 840P and 840C. On October 30, Mr. Harding filed a *Motion for Admittance of Pre-Filed Exhibits into the Record* and attached exhibits 811C, 814, 815, 819, 821C, 10825, 10826, and 10827.

On November 5, ATXI filed its *Objections to Late-Filed Exhibits and Response to Mr. Mark Harding's Motion for Admission of Pre-Filed Exhibits into the Record* (Response). The Response stated that ATXI did not object to McGinley-Farms Exhibits 952C and MS-7C, nor did it object to Harding Exhibits 812, 813, 820P, 825C, 828P, 829, 840P or 840C. The Response states that ATXI objected to all other exhibits filed.

ATXI's objection to Exhibit 825P is that it includes communications with a landowner other than Mr. Harding and includes personal information about that landowner. ATXI's objection to Exhibit 811C is that it was withdrawn at the hearing, is

labeled an already used exhibit number, is a portion of the original filed Exhibit number 811 and contains personal information about a landowner other than Mr. Harding. ATXI's objection to Exhibit 814 is that it is a duplicative exhibit that was offered and admitted at the hearing. ATXI's objection to Exhibit 815 and 819 is that they are attempts to supplement Mr. Harding's pre-filed testimony and relate to a matter beyond the scope of the grant of intervention to Mr. Harding. ATXI's objection to Exhibit 821 is that it is beyond the scope of Mr. Harding's intervention. ATXI's objection to Exhibits 10825, 10826 and 10827 are that they are attempts to supplement Mr. Harding's pre-filed testimony and relate to a matter beyond the scope of the grant of intervention to Mr. Harding. ATXI also generally objected to each of the late-filed exhibits filed on October 30 because they had not been offered at the hearing and no reason was given for them to be filed late.

## THE COMMISSION ORDERS THAT:

- 1. ATXI's objections are sustained.
- 2. Exhibits 952C, MS-7C, 812, 813, 820P, 825C, 826, 828P, 829, 840P and 840C are admitted.
  - 3. This order is effective when issued.
