**ORDER MODIFYING THE PROCEDURAL SCHEDULE AND  
DENYING MOTION TO SUSPEND THE PROCEDURAL SCHEDULE**

Issue Date: February 24, 2021

Effective Date: February 24, 2021

On January 20, 2021, the Commission issued its order establishing a procedural schedule in this case. That procedural schedule required the Complainants to file direct testimony no later than February 26, 2021. On February 19, 2021, Complainant and Respondent jointly filed a motion to suspend the procedural schedule pending an answer regarding Complainants' Motion to Compel filed January 25, 2021. The joint motion states that a new procedural schedule will be filed within three days of an order on the Motion to Compel. This order denies the motion to suspend the procedural schedule as unnecessary, because the Commission is issuing its order regarding the Motion to Compel on February 24, 2021. Rather than have the parties submit a new procedural schedule, the Commission is modifying the procedural schedule to allow additional time to file direct testimony and rebuttal testimony. The modified procedural schedule

dispenses with prefiled surrebuttal testimony as it may be done at the evidentiary hearing. The Commission will deny the motion to suspend the procedural schedule, and modify the procedural schedule.

**THE COMMISSION ORDERS THAT:**

1. The Joint Motion to Temporarily Suspend Procedural Schedule is denied.
2. The remaining procedural schedule is modified to provide as follows:

**Direct Testimony — Complainants** March 11, 2021

**Rebuttal Testimony — Respondents** March 24, 2021

**Rebuttal Testimony/Report — Staff** March 24, 2021

**Joint list of Issues, order of witnesses, order of cross-examination, order of opening** March 25, 2021

**Last day to request discovery** March 26, 2021

**Position Statements** March 29, 2021

**Evidentiary Hearing** April 1, 2021

**All parties Post-Hearing Briefs** April 16, 2021

3. The additional procedural requirements contained in ordered paragraph five of the Commission's January 20, 2021, Order Establishing Procedural Schedule and Other Procedural Requirements, not specifically modified by this order, remain effective.
4. This order shall be effective February 24, 2021.
